2009 Ann Arbor Championship Series

ELIGIBILITY

Entries are open to all male amateur golfers. There are no handicap index eligibility requirements. The field will be limited to 156 players.

Age: A player is required to list his age and date of birth on all entry forms. In addition to listing their ages, all players who are minors in the state they reside (e.g., Michigan, under the age of 18) must also list a parent / guardian and family physician with the appropriate phone number. The parent / guardian must also sign the submitted application.

Amateur: All players must conform to the USGA Rules of Amateur Status as specified in "The Rules of Golf."

FORMAT, SCHEDULE

Competition will be 54 holes of stroke play. All competitors shall play from the Senior Men's Championship teeing grounds.

Friday, July 17, 2009

18 holes Stroke Play.

Saturday, July 18, 2009

18 holes Stroke Play.

36 holes scores will determine flight and starting times.

Sunday, July 19, 2009

18 holes Stroke Play.

Cumulative scores will determine the 2009 Men's Champion and flight winners. Any tie for champion, runner-up, flight winners, or flight runner-up will be decided immediately by a sudden death play-off.

PRIZES

Trophies and/or gift certificates will be awarded to the champion, runner-up, 1st and 2nd round medalist, flight winners, and flight runner-up. Also, prizes will be awarded for individual hole contests. All prizes will conform to USGA Rules of Amateur Status. Awards will be presented following the completion of tournament play.

RULES OF GOLF

Play will be governed by the USGA "Rules of Golf," or Local Rules and Conditions so provided prior to the start of competition on each day of the Championship. Questions will be settled by the Rules Committee for the Championship, whose decisions shall be final.

Rules & Regulations

NON-METAL SPIKE POLICY

It is a condition of the competition that shoes with either traditionally designed spikes (regardless of composition, i.e., ceramic, plastic, etc.) or, regardless of design, spikes comprised either or partially of metal (if such metal may come in contact with the course) are prohibited during the stipulated round.

GOLF BALLS; DRIVE HEADS

Only brands of golf balls on the most current USGA List of Conforming Golf Balls and driver heads on the most current USGA List of Conforming Driver Heads may be used. These lists are updated and may be found on the USGA website at www.usga.org.

DISTANCE MEASURING DEVICES

In this Championship, a player may obtain distance information by using a device that measures distance only. Use of a device designed to measure other conditions is strictly prohibited.

CADDIES; TRANSPORTATION

Competitors may provide their own caddie for championship rounds. Caddies are not available at Leslie Park Golf Course. Caddies are not permitted during practice rounds. Competitors are permitted to use motorized transportation during championship rounds. Players, especially those using caddies, are encouraged to familiarize themselves with Decisions 6-4/2.5, 6-4/3, 19/1, 19/2, and 33-8/4 of the USGA Decisions on the Rules of Golf.

STARTING TIMES

Competitors must be at their assigned tee and ready to begin play at the time laid down by the committee. Competitors will be notified of their starting time by e-mail approximately one week prior to the championship. The optional condition in Appendix I of the "Rules of Golf" shall be in effect if a player arrives at their starting

hole ready to play within five minutes of starting time, the penalty shall be Two Strokes instead of Disqualification.

TOURNAMENT INFORMATION

Information concerning pairings, starting times, etc., will be posted online at www.a2golf.org approximately 7-14 days prior to the tournament. If you have not received your information within seven days of the event, it is the player's responsibility to contact Leslie Park Golf Course.

REFUND POLICY

Refunds will be granted according to the schedule below. The Tournament Director reserves the right to grant exceptions to the stated policy in situations including, but not limited to injury, illness, and death in the family.

Time of Request / Refund

Prior to posted registration date - 100%

After posted deadline, 10 days prior to start of tournament - 50%

After posted deadline, 5-9 days prior - 25%

After posted deadline - less than 5 days prior to start of tournament - 0%

Administrative Fee

Prior to posted registration date - \$10.00

REGISTRATION

Registration is open to competitors beginning June 1, 2009. Return entry forms by mail, fax, or in person to Leslie Park Golf Course. **The entry fee is \$150.00. Application form and entry fee must both be received by July 3, 2009 to constitute complete registration.**
